2010 FLORIDA BUILDING CODE (FBCR) RESIDENTIAL RAMP CONSTRUCTION

FBCR 311.8.1 Maximum Slope: **Type II.** Handrails with a perimeter greater than $6^{1}/_{4}$ inches (160 mm) shall have a graspable finger recess Ramps shall have a maximum slope of 1 unit vertical in 12 units horizontal. (8.3% slope) area on both sides of the profile. The finger recess shall begin within a distance of $\frac{3}{4}$ inch (19 mm) measured vertically from the tallest portion of the profile and achieve a depth of at least $\frac{5}{16}$ inch (8 mm) within $\frac{7}{8}$ inch (22 mm) below the widest portion of the profile.
