## INSTRUCTIONS FOR 2018-2019 NO COST SPAY/NEUTER PROGRAM



**Dear Putnam County Resident:** 

Thank you for considering spaying or neutering your dog or cat. Funds for this spaying neutering grant program come from the purchase of the specialty license plates "Florida Animal Friend". Please encourage your family and friends to consider purchasing one of these license plates so they can continue to fund these worthwhile projects.

To qualify for this grant program you must live in Putnam County and your household family income must not exceed the following limits:

If you meet these qualifications, please fill out the application on the reverse side of this form and return the completed application along with copies of the items requested to Lisa Suarez or Brenda Gallo, Putnam County Planning & Development Services, 2509 Crill Ave, Suite 300, Palatka, phone number (386) 326-7166. \* <u>Applications may be submitted at either</u> <u>locations, Monday through Thursday from 8:30am – 4:00pm; however vouchers may only</u> <u>be picked up from the Planning & Development Services office on Fridays.</u>

When you bring the completed application to the office, you will receive a voucher for each dog or cat you will have spayed or neutered. You will have to have this voucher to give to the veterinarians participating to have your dog or cat spayed or neutered. The vouchers will only be valid for 60 days from the date of issue.

This is a no cost spaying/neutering program, however, you must provide proof that your dog has current rabies and bordetella vaccinations and your cat has a current rabies vaccination or you will be required to pay for these vaccinations. Rabies vaccinations are \$15 and bordetella vaccinations are \$17.

IMPORTANT – YOU MUST RESPOND QUICKLY! Vouchers will be issued on a first come, first serve basis.

\* Applications may be submitted at either locations, Monday through Thursday from 8:30am – 4:00pm; however vouchers may only be picked up from the Planning & Development Services office on Fridays.

NOTE: The grant will pay the cost of spaying or neutering only. Proof of current rabies and bordetella inoculations for a dog and rabies inoculation for a cat, through a licensed veterinarian must be provided to the <u>veterinarian</u> before the surgery. If not, the rabies and bordetella vaccine must be given at the time of the alteration for an additional \$15.00 for rabies and \$17.00 for bordetella. THIS COST IS NOT COVERED BY THE GRANT AND MUST BE PAID BY THE DOG/CAT OWNER. Rabies tag fees are exempt for this program.

If the female dog or cat is pregnant, be aware that the veterinarian WILL charge an additional fee for the spaying. THIS ADDITIONAL FEE WILL BE THE RESPONSIBILITY OF THE OWNER.
