## The Do's and Don't of a clean neighborhood



Don't let your trash become a nuisance to the neighbors. Garbage bags are an easy target for stray animals



Overgrown grass can welcome unwanted animals, rodents and snakes



Properly dispose of all unwanted household items by contacting Sanitation at 386-329-0395



All vehicles must be properly tagged and road ready.

With little effort from you and your neighbors, you will maintain a healthy and safe place for children and grand-children to play.



Make sure that your waste receptacles have tight fitting lids.



Well maintained lawns and homes are inviting to visitors and prospective buyers.



Homeowners can drop off their yard waste & junk items at the landfill, for no charge. (5 tires per year)



Inoperable vehicles, tires, auto parts, appliances, furniture and boxes must be in an enclosed building

## Top 10 Code Violations

These first 5 violations are potential life safety issues:

- 911 Address not posted
- Un-Permitted Pools
- Un-Permitted Work
- Unsafe Electrical
- Unsafe Housing

The following 5 code violations are the most common complaints in residential neighborhoods:

- No zoning permit for structures less than 150 sq. ft., decks or concrete
- Care of Premises / Junk Vehicles
- Occupied RV's
- Fencing
- Yard Sales (2 per calendar year allowed)
