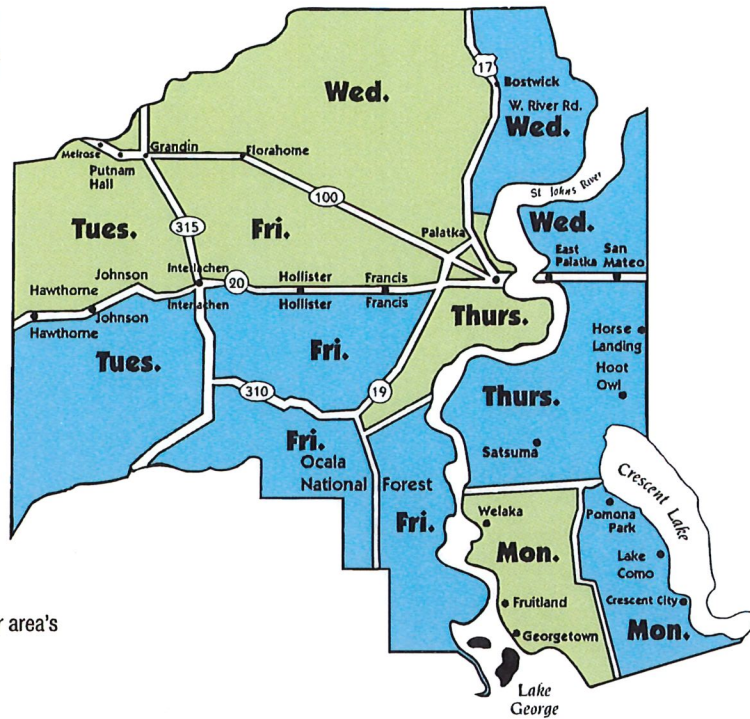


2023-2024 Yard Trash Collection Schedule

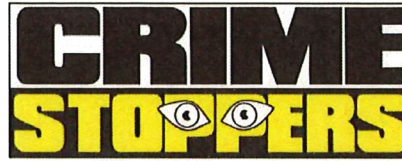

REASONS MATERIALS MIGHT NOT BE COLLECTED

- ☐ Garbage receptacle exceeds 32-gallon capacity
- ☐ Garbage receptacle exceeds 50 pounds each.
- ☐ Garbage was not out by 6:00 AM
- ☐ Garbage was not placed within 6 feet of curb or where garbage is serviced
- ☐ Recyclable materials mixed with trash.
- ☐ Recyclables were not put out by 6:00 AM.
Please note: the hours of collection are from 6:00 AM to 6:00 PM
- ☐ Recyclables were not placed within 6 feet of service area.
- ☐ Recyclable materials were not in an appropriate container.
- ☐ Yard trash is contaminated with other debris (lumber, stone, garbage, paper, etc.).
- ☐ Yard trash was not placed within 6 feet of service area. BACK DOOR SERVICE IS NOT APPLICABLE TO YARD TRASH.
- ☐ Carpet exceeds 6 feet in length, is not bundled, rolled or weighs more than 50 lbs.
- ☐ Yard trash was not out by 6:00 AM.
- ☐ Yard trash pile exceeds 6 cubic yards (about two pick-up truck loads). The remainder of the pile will be picked up on your next scheduled yard trash day, not to exceed 6 cubic yards per pickup.

Please note that recyclable materials include:
(NO GLASS, PLASTIC BAGS OR
STYROFOAM SHALL BE COLLECTED)

- newspaper
- magazines
- phone books
- tin or bi-metal (ferrous) cans
- plastic jugs or bottles
- corrugated cardboard
- aluminum cans
- aerosol cans
- Anyone needing a new replacement recycling bin should call our office for delivery
- ☐ Your yard trash exceeds 6 ft. in length and/or 4in. in diameter
- ☐ Yard trash that is not part of normal yard maintenance will not be collected (i.e. land clearing, tree removal, land development, building demolition, or home improvement).
- ☐ Grass clippings, leaves, pine needles need to be containerized (i.e. put in a receptacle or plastic bag) and cannot exceed 50 pounds each.

Additional Services— Waste Pro does provide free estimates & charge services for large yard waste and trash piles that exceed the normal pickup limits

Holiday Schedule— New Years, Memorial Day, Forth of July, Labor Day, Thanksgiving, Christmas are company and county holidays. If your pick up day falls on one of these days, the next day will be your pick up day. All other pick ups that week will fall back one day. (Example: Tuesday to Wednesday, Wednesday to Thursday & ect. for the remainder of that week only.)

Tires— Not part of your normal pick up. They can be brought to the Putnam County Landfill.

Construction Debris— Will not be collected curbside (i.e. plywood, boards, sheetrock, cabinets, etc.)

Please note that white goods, carpet and furniture shall be picked up with your garbage.
